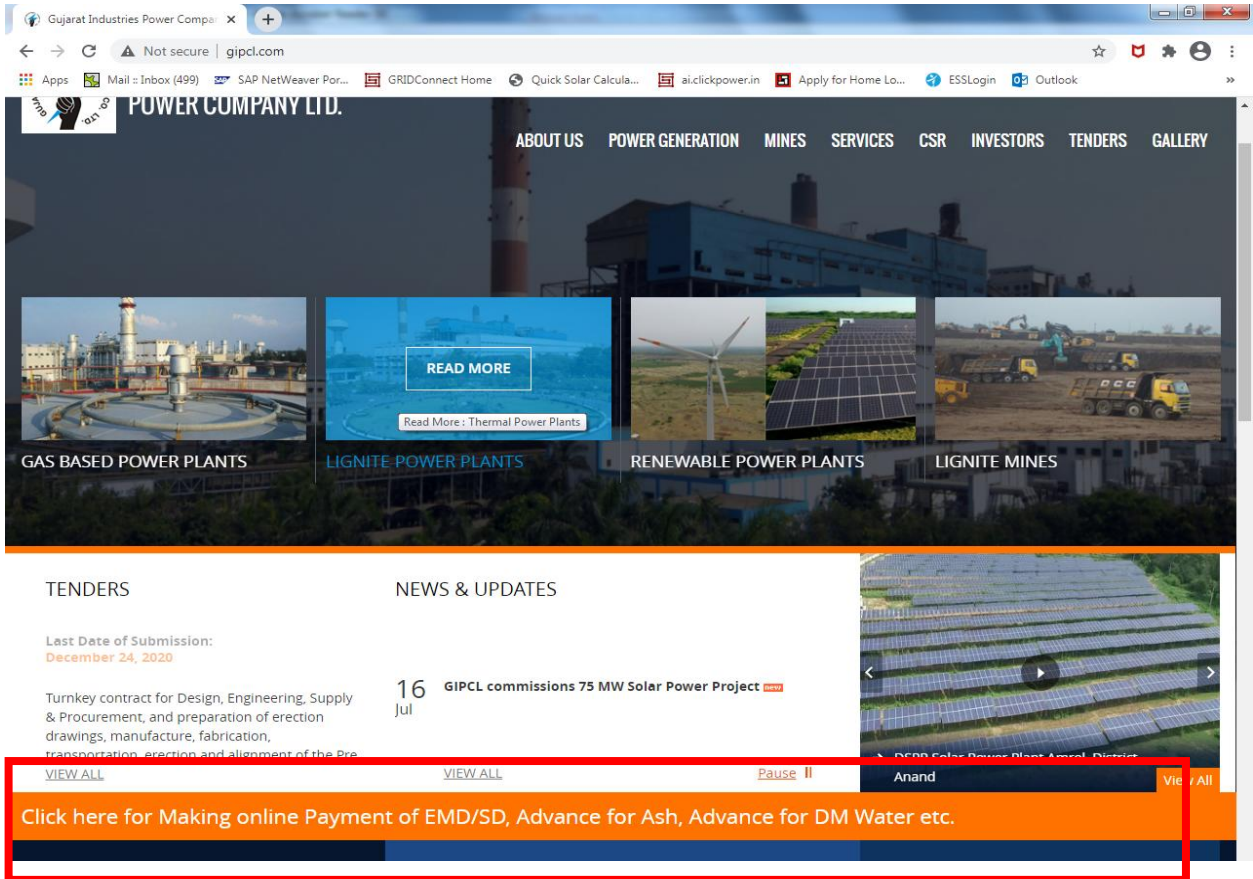

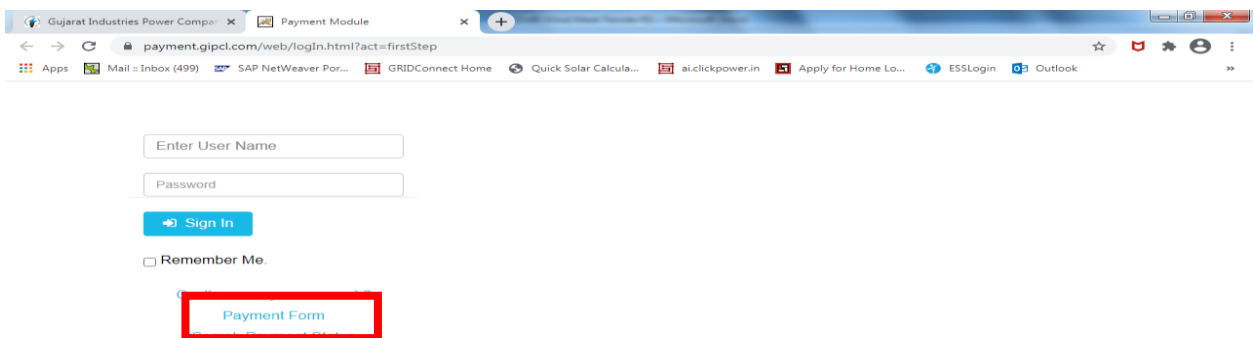

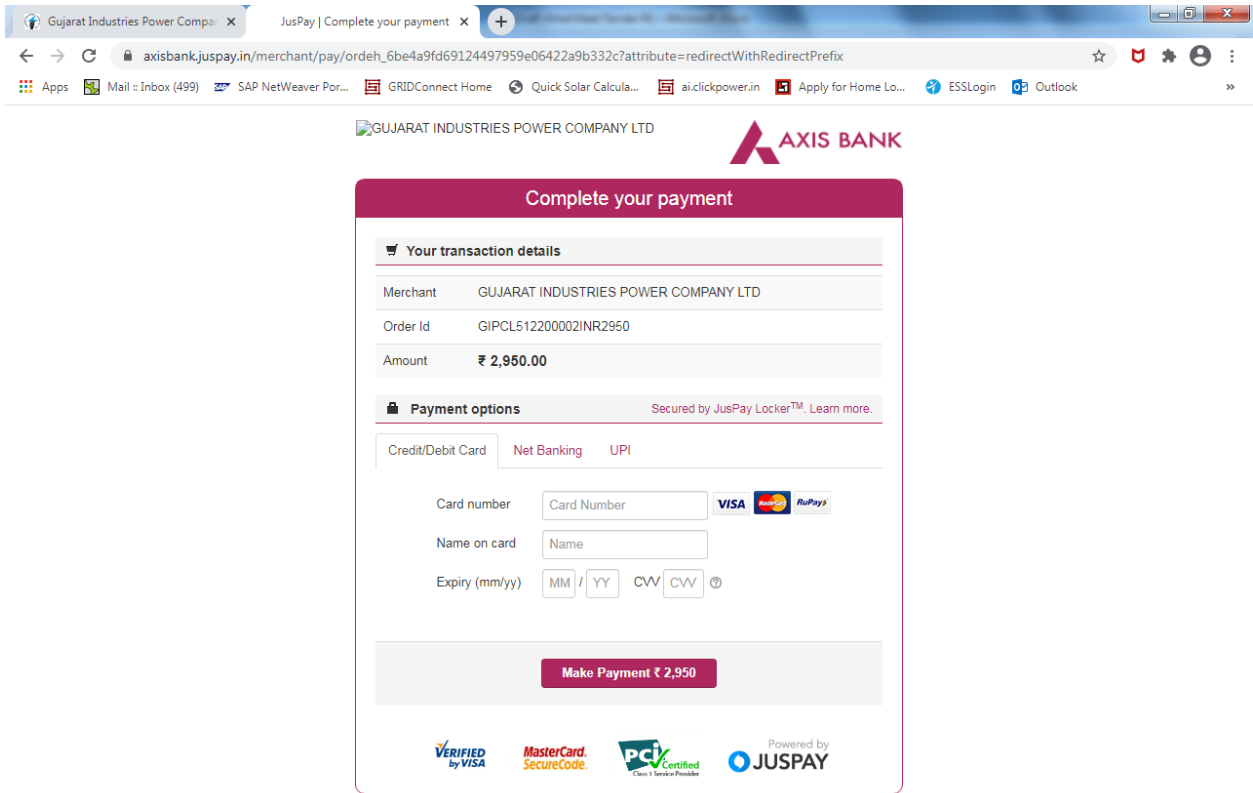

9. Bidders must quote clearly and strictly in accordance with the price schedule outlined in "Price Bid Format" of Bid Document; otherwise the Bid will be summarily rejected.
10. If any of the clauses in the BEC contradict with other clauses of the Bid Document elsewhere, then the clauses in the BEC shall prevail.
11. If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
12. The bidders must quote their charges/ rates in the manner as called for vide "Price Schedule" under Section - 8 of Volume-I under this document.
13. Total quoted EPC/Lumpsum contract cost as per Schedule of Rates including all applicable statutory levies, GST and duties if any



**B. EVALUATION CRITERIA:**

1. GIPCL will examine the Bid to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the Bid is generally in order.
2. Prior to the detailed evaluation, GIPCL will determine the substantial responsiveness of each Bid. A substantially responsive Bid is one which conforms to all the terms and conditions of the Tender Documents without material deviations. GIPCL's determination of a Bid's responsiveness is to be based on the contents of the Bid itself without recourse to extrinsic evidence.
3. If the Bid is not substantially responsive, it will be rejected by GIPCL and may not subsequently be made responsive by the Bidder by correction of the nonconformity.
4. GIPCL will evaluate and compare Bids which have been determined to be substantially responsive.
5. Evaluation of both Techno-Commercial (un-priced) bids and priced bids shall be done separately
6. Price Bids of only Techno-commercial acceptable bids shall be considered for further evaluation.
7. The Bid with the Lowest Lump sum price (Total EPC Contract Price) shall be considered as L-1. The Bid with next highest value shall be considered as L-2 and so on.
8. Lowest Five (5) eligible bidders or 50% out of total eligible Bidders (rounded to the next higher whole number), whichever is higher shall be invited for participation in e-Reverse Auction.
9. Decrement value and duration for the e-Reverse Auction shall be informed to the qualified bidders before start of e-Reverse Auction. The L1 shall be put up for starting e-Reverse Auction. e-Reverse auction shall be for reducing the Lumpsum price and the bidders have to reduce their Lumpsum price in decrement of value as decided before start of e-Reverse Auction.
10. The reduction offered by the Bidder during e-Reverse Auction Process on the Lump price shall be considered for as an equivalent reduction in Total EPC Contract Price only. Accordingly, final EPC Contract Price will be arrived for all contractual purposes.
11. Upon completion of e-Reverse Auction process, L1 bidder for the CCTV Surveillance System work shall be decided. The L1 bidder after e-Reverse Auction shall have to submit break-up in line with their quoted price bid within three (3) days.
12. In no case, a Bidder shall have the right to claim to be the Successful Bidder for its Bid.

The identity of the insurers and the form of the policies shall be subject to the approval of the Owner, such approval not to be unreasonably withheld. The inability of the insurers to provide insurance cover in the sums and with the deductibles and other conditions as set forth below, shall not absolve the Contractor of his risks and liabilities. However, in such a case the Contractor shall be required to furnish to the Owner documentary evidence from the insurer in support of the insurer's inability as aforesaid.

#### **(a) Transit Insurance Policy:**

(I) Deleted

(II) Transit Insurance Policy for indigenous equipment

Similarly, Transit Insurance Policy shall be taken wherein only inland transit is involved for the movement of Plant and Equipment including mandatory Spares supplied from within India. The policy shall cover movement of Plant and Equipment, materials including mandatory Spares from the manufacturer's works to the project's warehouse at final destination site. Inland Transit Clause (ITC) 'A' along with Strike Riots & Civil Commotion (SRCC) extension cover shall be taken.

(III) If during the execution of Contract, the Owner requests the Contractor to take any other add-on cover(s)/ supplementary cover(s) in aforesaid insurance, in such a case, the Contractor shall promptly take such add-on cover(s)/ supplementary cover(s) and the charges towards such premium for such add-on cover(s)/ supplementary cover(s) shall be reimbursed to the Contractor on submission documentary evidence of payment to the Insurance company. Therefore, charges towards premium for such add-on cover(s)/ supplementary cover(s) are not included in the Contract Price.

(IV) The Contractor shall take the policy in the joint names of Owner and the Contractor. The policy shall indicate the Owner as the beneficiary. However, if the Contractor is having an open policy for its line of business, it should obtain an endorsement of the open cover policy from the insurance company indicating that the dispatches against this Contract are duly covered under its open policy and include the name of the Owner as jointly Insured in the endorsements to the open policy.

#### **(b) Construction All Risk Policy/Contractor All Risk Policy:**

(I) The policy should cover all physical loss or damage to the facility at site during storage, construction and completion covering all the perils as provided in the policy as a basic cover and the add on covers as required.

(II) The Contractor shall take the policy in the joint name of Owner and the Contractor. All these policies shall indicate Owner as the beneficiary. The policy shall be kept valid till the date of the Operational Acceptance of the project and the period of the coverage shall be determined with the approval of the Owner.

If the work is completed earlier than the period of policy considered, the Contractor shall obtain the refund as per provisions of the policy and pass on the benefit to Owner. In case no refund is payable by the insurance company then the certificate to that effect shall be submitted to Owner at the completion of the work.



- (III) The following add-on covers shall also be taken by the Contractor:
  - i) Earthquake
  - ii) Terrorism
  - iii) Escalation cost (approximately @10% of sum insured on annual basis)

If during the execution of Contract, the Owner requests the Contractor to take any other add-on cover(s)/ supplementary cover(s) in aforesaid insurance, in such a case, the Contractor shall promptly take such add-on cover(s)/ supplementary cover(s) and the charges towards such premium for such add-on cover(s)/ supplementary cover(s) shall be reimbursed to the Contractor on submission documentary evidence of payment to the Insurance company. Therefore, charges towards premium for such add-on cover(s)/ supplementary cover(s) are not included in the Contract Price.

(c) Automobile Liability Insurance

The Contractor shall ensure that all the vehicles deployed by the Contractor or its Subcontractors (whether or not owned by them) in connection with the supply and installation of



the Facilities in the project are duly insured as per RTA (Regional Transport Authority) act. Further the Contractor or its Subcontractors may also take comprehensive policy (own damage plus third party liability) of each individual vehicles deployed in the project on their own discretion in their own name to protect their own interest.

(d) Workmen Compensation Policy:

- (I) Workmen Compensation Policy shall be taken by the Contractor in accordance with the statutory requirement applicable in India. The Contractor shall ensure that all the workmen employed by the Contractor or its Subcontractors for the project are adequately covered under the policy.
- (II) The policy may either be project specific covering all men of the Contractor and its Subcontractors. The policy shall be kept valid till the date of taking over of the works by the Owner.

Alternatively, if the Contractor has an existing 'Workmen Compensation Policy' for all its employees including that of the Subcontractor(s), the Contractor must include the interest of the Owner for this specific Project in its existing 'Workmen Compensation Policy'.

- (III) Without relieving the Contractor of its obligations and responsibilities under this Contract, before commencing work the Contractor shall insure against liability for death of or injury to persons employed by the Contractor including liability by statute and at common law. The insurance cover shall be maintained until all work including remedial work is completed including the Defect Liability Period. The insurance shall be extended to indemnify the Principal for the Principal's statutory liability to persons employed by the Contractor.

The Contractor shall also ensure that each of its Subcontractors shall effect and maintain insurance on the same basis as the 'Workmen Compensation Policy' effected by the Contractor.

(e) Contractor's Plant and Machinery (CPM) Insurance

The Owner (including without limitation any consultant, servant, agent or employee of the Owner) shall not in any circumstances be liable to the Contractor for any loss of or damage to any of the Contractor's Equipment or for any losses, liabilities, costs, claims, actions or demands which the Contractor may incur or which may be made against it as a result of or in connection with any such loss or damage.

The Owner shall be named as co-insured under all insurance policies taken out by the Contractor, except for the Third Party Liability, Workmen Compensation Policy Insurances, and the Contractor's Subcontractors shall be named as co-insureds under all insurance policies taken out by the Contractor except for the Cargo Insurance During Transport, Workmen Compensation Policy Insurances. All insurer's rights of subrogation against such co-insureds for losses or claims arising out of the performance of the Contract shall be waived under such policies.
